President's Column Systemic Health Care

Now that we are definitely into the summer season, it would appear that we have survived the H1N1 epidemic of 2009...at least for now. Perhaps one of the silver linings that will come from this experience is a renewed understanding of the importance of getting the influenza vaccination this fall.

The other important lesson that should not escape us as Family Physicians is that we are part of a larger "system" of health care. We became aware of the development of this epidemic not because we all noticed the surge of late Spring influenza patients but from watching CNN and receiving bulletins from the CDC. In a way, the minor panic that took place in the state and across the nation was due to a major increase in awareness of what was happening in Mexico, the United States, and around the globe brought to us in a constant flow of information via the mass media. The minor panic was a bit of a hassle as a result of the inquiries by our patients; but, overall it reflected the significant increased capability that the surveillance system has developed primarily after 9/11.

Throughout the epidemic, we were assisted in our daily work by the CDC in concert with the World

Health Organization analyzing all of the incoming data and developing logical, scientific recommendations about epidemic suppression and pharmacologic treatment. The information is still being analyzed but it could very well be that this epidemic was significantly slowed as a result of the upgraded surveillance and response system that we now have as part of our medical practice.



As a vibrant medical specialty of the 21st century, Family Medicine must embrace this relatively new "systemic" approach to the practice of medicine. On the horizon are user-friendly Internet systems that will depend on each of us reporting anything that we see in our daily practices that could be an early epidemic of contagious disease. Such things as rash, fever, GI symptoms, myalgia, pneumonia, etc. will be systems that we will want to enter into the database that will be monitored by advanced software programs looking for patterns of things like a local salmonella outbreak or a global pandemic.

What an exciting time to be a Family Physician! Hope to see all of you at the Ruidoso Conference to learn about a myriad of cutting-edge developments applicable to our practices.

NMAFP Takes Trip to Congress Amidst Flurry of Healthcare Reform

The AAFP hosts a national Congressional Conference each May to bring Family Doctors from every state to discuss healthcare with members of Congress. This year they found many eager listeners ready to discuss proposals. It is remarkable that primary care, long under-appreciated and under nourished, is being recognized for its fundamental importance to U.S. healthcare.

Four of us represented New Mexico. Martha McGrew, MD, Chair of the Department of Family and Community Medicine at UNM, and two of her faculty members, Isabel Lopez-Colberg, MD and Tiffany Snyder, DO joined me on the visits. We were particularly pleased to meet in person with Representative Martin Heinrich (District 1) and Representative Harry Teague (District 2). We spoke with Justina Trott, MD, who is a practicing general internist in Santa Fe and the Robert Wood Johnson Health Policy Fellow in Senator Bingaman's office. We also met with Fern Goodlove in Senator Tom Udall's office. All of them were very receptive.

We outlined a path to reform. First, everyone, by some means, must have healthcare coverage and access to healthcare. Second, Congress must commit a significant portion of the graduate medical education-funding stream to primary care with targeted, protected and accountable money. Third, they must revive Title VII funding for primary care. These two changes would help bolster primary care education and medical student recruitment. Finally, Congress must replace the dysfunctional SGR formula for physician payment with a workable system that ensures Medicare patients will have access to medical care. With these solutions in place, primary care specialties would grow

and be able to provide the service our nation deserves.

There was also a lot of interest in how the patient-centered medical home will be an answer to our current system's inconsistent quality, high costs and payment inequities that so disadvantage primary care. In this model, the patient experience becomes the focus of a rigorous improvement project. The medical home emphasizes prevention, teamwork for improving both access to care of all kinds as well as management of chronic diseases, and much better communication within our healthcare system through nimble, interoperable electronic records. An enhanced, three-part payment scheme will help drive its success. Almost every state has demonstration projects in varying stages (including a new one passed by the NM legislature this year), and Medicare will launch its demonstration project in 2010.

At the conference, there was a palpable sense of urgency and an expectation that fundamental healthcare reform was in the offing...this year. Speakers looked back to the hopefulness of the Clinton healthcare reform effort in 1993, but the dramatic birth of Medicare in 1965 may be the more appropriate milestone to remember. A lot of work remains, and we will soon see if Congress can achieve an equally profound success. ■

Medical Students Active in Promoting Family Medicine

The Family Medicine Interest Group (FMIG) at the University of New Mexico has been active this spring semester by promoting and exposing medical students to opportunities in Family Medicine. New FMIG faculty advisors, Dr. Tiffany Snyder, Dr. Isabel Lopez-Colberg and Edward Merta, have helped the FMIG officer team develop strategies to impact medical students as well as reach out to the community.

This spring semester two lunch seminars were presented to the UNM Medical Students. Alice Hulebak, a former UNM School of Medicine graduate and a current Resident in the Alaska Residency Program spoke to students about her residency. Her presentation provided interested students with information on getting into a Family Medicine Residency program as well as information about wilderness and rural medicine. Dr. Alfredo Vigil, the New Mexico Department of Health Secretary and current UNM School of Medicine clinical faculty, spoke about "Challenges in Rural Health in New Mexico". Dr. Vigil's experience in New Mexico provoked much interest among the medical students, and his talk about rural health provided medical students with valuable information concerning the need for Primary Care Physicians in New Mexico.

The Family Medicine Interest Group has assisted the UNM American Society of Health-System Pharmacists Group in collecting donations for children that are patients of Captain Jack Miller, a military RN in a Baghdad Hospital. FMIG is also teaming up with the surgery interest group to provide a suturing workshop to first-year medical students who, in July, will begin their 8 week Practical Immersion Experience in rural communities across the state of New Mexico. Medical Students are also anticipating the New Mexico Academy of Family Physicians Family Medicine Seminar in Ruidoso, NM as well as the National Conference of Family Medicine Residents and Students in Kansas City, MO, which will take place in July and August. Family Medicine Resident Report

Another year of graduate medical education is coming to a close. Many of us graduating this June have finalized our decisions regarding where we will begin our service as physicians. Luckily for the people of New Mexico, many of the graduating seniors from the Family Medicine programs in our state are choosing to stay and serve the people here. From the University of New Mexico program, nine of the fourteen graduating seniors have chosen to stay in New Mexico. From the Santa Fe program, all three of the graduating residents will be practicing in New Mexico. From the Roswell program at least two of the four seniors will remain in our state. And from the Las Cruces program, four of the five graduating seniors, including myself, have decided to stay and practice in New Mexico. I am sure I speak for my fellow graduates when I say we are honored to have the opportunity.

Our state also fared well in the Match this year. All of the positions in all four programs in New Mexico were filled. This is testimony to the hard work by the programs to spread the word out about the opportunities for quality training in Family Medicine here in New Mexico.

Unfortunately Family Medicine did not fair as well as we had hoped nationally in the Match this year. According to the AAFP's 2009 Match Summary and Analysis, 99 fewer Family Medicine positions were offered in the Match this year and 75 fewer positions were filled when compared to 2008. For graduates of US medical schools, 89 less chose Family Medicine this year as compared to 2008. Internal medicine-categorical and internal medicine-pediatrics also saw a decline in the number of US graduates filling positions, whereas pediatrics saw a slight increase. In comparison, the number of positions filled in anesthesiology was four times

what it was in 1996.

This is obviously disappointing and disturbing. In a statement released in response to these results, AAFP President Ted Epperly, MD, stated "This decline has nothing to do with the value of primary care and everything to do with a system that claims to support primary care but fails to actually act on its pronouncements." He goes on to say, "Research has demonstrated unequivocally that the world's successful health care systems depend on primary care. With a ratio of 70 percent subspecialists to 30 percent primary care physicians, the American health care system is upside down. No health care reform can succeed unless we bring both financial and actual access to the primary care physicians that provide more than 80 percent of all health care services Americans need."

While Dr. Epperly and the AAFP work to combat the current and worsening shortage of primary care physicians, I believe there are a few things we can do as residents. First, we can act as mentors for medical students and college students considering medicine. Show them why Family Medicine and primary care are essential and why you have chosen it as your specialty. Second, work with and support your local FMIG. These are students already dedicating themselves to Family Medicine and they need our encouragement. Third, be willing to precept medical students once you graduate and begin practicing. There is no greater testament to Family Medicine than a good Family Doctor.

I want to congratulate those graduating seniors from all of the programs in the state and wish them happiness and prosperity as they begin their careers. I also wish to say a special thank you to those choosing to stay in New Mexico. I look forward to joining you as a Family Physician serving the people of our state. ■

FPs Can Apply for NHSC Loan Repayment Funds Now

Former Corps Doc Attests to Program's Value

June 2 is a big day for new family physicians who could use some help getting their educational loans paid back and are seeking a unique service opportunity. Of a total of \$300 million allocated to the National Health Service Corps, or NHSC, under the American Recovery and Reinvestment Act of 2009, some \$200 million is slated to go to the NHSC Loan Repayment Program, or LRP. Starting today, physicians can apply for the NHSC LRP funds.

Primary care physicians who serve in federally designated health professional shortage areas offer a safety net to the medically underserved.

In exchange for two years of service at an eligible site in a federally designated health professional shortage area, the program offers repayment of qualifying educational loans of as much as \$50,000 for primary care clinicians, including allopathic or osteopathic physicians, who provide full-time clinical services.

Clinicians who stay at the designated sites longer may be eligible to apply for additional years of support.

The NHSC is administered by the Health Resources and Services Administration, which is charged with increasing access to health care for people who live in medically underserved areas.

Beginning now through September 2010, or until the funds are expended, NHSC LRP awards will be available on a first-come, first-served basis. There are several new features of the program.

- More than 7,000 currently



eligible service sites will post additional new vacancies eligible for loan repayment awards.

In addition, the NHSC is approving more sites every day.

- For the first time in the program's history, primary care clinicians do not need to be employed at the site at the time of application.
- Most applications, so long as they are accompanied by all supporting documentation, will be processed within eight weeks of receipt.

AAFP member David Hoffman, D.O., of Chambersburg, Pa., started work at the then-new Keystone Health Center in Chambersburg in 1994 as a physician in the NHSC LRP. Eventually, he became medical director of its family medicine clinic.

Fifteen years later, the self-professed one-time "city boy" from Philadelphia is still in the borough of almost 18,000 in rural south central Pennsylvania. And Hoffmann says he and his family enjoy it.

He started the Hospitalists of Franklin County in 2004, a group of physicians based at Chambersburg Hospital, and works part-time as medical director of Keystone's HIV clinic.

Hoffman credits the NHSC LRP for paying back the lion's share – \$75,000 – of his \$110,000 educational loan debt. The \$35,000 balance was paid off through a state program.

"Since I've moved to Chambersburg, I've never had to pay any medical school debt out of my pocket. I went through federal and state programs and my loans were done. It was win-win at the end of the day." ■
